## HOW DO I REGISTER MY GOATS AT STUDBOOK ?

1. Register with SABGBA at Studbook to obtain a prefix (e.g. a farm name "Bokfontein") (send an email to the Office and ask for Studbook application forms. Send the completed application forms back to the Office with proof of payment – info@boerboksa.co.za) .
2. You already own a herd characteristic number (stud number)
3. Goats must be correctly numbered consisting of 3 parts. (PLEASE REMEMBER that all animals must have an ID number before they can be selected!)
  - a) Herd characteristic no. (Stud No.) 617
  - b) Annual figure. For 2023 it is 23
  - c) A serial number on goats starts each year at 0001. Complete number will then be: 617 10 0001

Send the Inspection Report to the Office. The Office sends the inspection report to Studbook for survey of the animals. The following must appear on the inspection report:

- I Correct ID (next to the animal's plate no if he has 1.)
- II Gender
- III ID number of mother/ID number of father.
- IV Date and proof that the animal has been selected by a SABGBA inspector.

Note: Goats that are on the Intergis system by ARC can also register with Studbook after selection.

## Information regarding new format of inspection of goats:

- Any section A ewe born before 2024 can get a stud plate. Doesn't matter if she is selected after 2024.
- Any division B ewe born before 2026 can get a stud plate. Doesn't matter if she is selected after 2026.
- Any section A ram born before 2023 can get a stud plate. Doesn't matter if he is selected after 2023.
- Any section B ram born before 2024 can get a stud plate. Doesn't matter if he is selected after 2024.

All the animals retain their stud plates and can participate in national and world shows.

Color tag System - No animal will be tagged without an ID plate (Year + no - eg 23-01)

- **Blue** - A registered animal that phenotypically meets the requirements of a stud animal as well as the registration timeline requirements as communicated.
- **Green** - All herd animals (including Type D breeders)

**Herd Inspection report codes as follows:**

K - Herd conformation (all animals with herd conformation regardless of registration)

KR - Herd Registration (Stud conformation, does not meet registration requirements - All breeders, including Type D breeders)

KSP - Herd Weaning (Stud Conformity, Herd Weaning)

KK - Herd color (Stud conformation, herd color)

Recorded as such on inspection report with above codes.

**Red** - "Fit to Travel" tag - no obvious cull defects, and meets minimum requirements for export purposes (applicable to animals too young for inspection)

Farm inspections - Breeder must request if he/she wants to have goats tagged - breeder responsible for costs from July 2024\*

**GROUP D BREEDER:**

1.1.1 A buck that meets the breed standards.

1.1.2 This herd will not be registered with S A Stud Book.

1.1.3 Certain conditions will apply under which this member maintains his membership within the breeders association can retain, namely:

(a) No participation in a national or world show.

(b) No presentation of animals at any national auction or show auction.

(c) Animals within this herd will only be vetted or vetted every two years selection and be plated with the same SABGBA plates.

(d) Any animals from this herd will, if registration takes place, after the entry date be included as base animals, with at least 12 (twelve) months' written notice of the entry date to the members.
